**Ribbons and Prize Money** Ribbons will be awarded to 6th place. Equine Canada rules state that there must be a minimum of three entries to run a class and if there are less than 5 in a class the prize money will be reduced by

50%. Prize money WILL be paid for Bronze level division classes, including the Walk/Trot. Prize Money will not be paid for Equitation/Medal Classes or Hunter Schooling Classes. For ALL Divisions, prize money will be paid as follows:

**Eligibility for Competition as well as Year-End Awards SILVER and BRONZE COMPETITION**

- **All RIDERS and OWNERS** must provide proof of 2021: EC Silver or Bronze (to match the respective division in which they are competing), OEF (Ontario Equestrian Federation) and THJA (South East Zone) memberships must be provided prior to competing at ALL SHOWS. All RIDERS and OWNERS must be current members in good standing before the first horse show for points to apply and remain in good standing all year long.
- All Junior Riders must provide a copy of his/her birth certificate prior to competing at the first show.
- Amateur riders must have a valid "Amateur Status" designation (as shown on the EC membership card).
- Horses/ponies must have a valid EC recording number and valid sport license for all silver divisions except the Hack Division. Ponies will need a permanent measurement card. Any competitors arriving at the show without a valid horse recording number or memberships MUST purchase a temporary License and/or Recording number.
- Horse/Rider combinations must compete in a minimum of 3 of the 6 shows in the respective division/class. The top seven from each silver division will be eligible to compete at Championships.
- Completed championship entries must be provided to the Zone no later than the Monday after the last show.

**Rules and Regulations: Administration**

**Entries are to be completed online at [showgroundslive.com](http://showgroundslive.com) ON or BEFORE the SUNDAY at 4PM PRIOR TO EACH**

**SHOW to avoid the \$50.00 post entry fee.**

**\* STALL FEES ARE NON-REFUNDABLE after booked.**

Entry and administration fees will be returned ONLY if the show office receives the cancellation in writing within 24 hours of the class with proper medical documentation (vet scratch). However, a \$30.00 scratch fee will be charged. Stalls are non-refundable – there are no exceptions. A competitor that does not show and does not provide the required medical documentation (a veterinary certificate or doctor's note) will be charged full entries and will be required to pay the Administration fee and stall fee. **All unpaid fees will be considered an outstanding account until paid in full.** Once a horse has entered the show grounds, refunds will not be granted unless authorized by the show committee. Any classes/divisions entered but not completed will be charged. There will be no refund for classes scratched on the day of competition for any reason. You may change from one class to another or change from one division to another at no additional charge.

- If a horse/rider is entered prior to Monday of the show, additions can be made to entries up until the start of the affected division/class without post entry penalties.
- All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.
- Competitor numbers will NOT be issued without full payment or a signed open cheque left with the show secretary to cover all charges and fees incurred by the exhibitor.
- Entry forms must be filled out and signed by the competitor or agent and/or guardian for a junior rider before competitor numbers are issued.
- All outstanding accounts must be paid in full before an entry can be accepted and processed. All accounts must be settled before the next show, otherwise entries will be denied, and no points awarded. Please note that any outstanding accounts at year-end will not be eligible to compete in the Specialty classes or receive year-end awards.
- NSF cheques: \$50.00 bank penalty charges will be added to all accounts paid with cheques that are returned from the bank for any reason.
- Show management reserves the right to change or amend show scheduling up to one hour prior to the designated class.
- Veterinarian and/or Farrier bills incurred at the horse show (medical emergencies, farm calls etc.) must be settled preferably the day the costs are incurred, but no later than 2 weeks after the event. All unpaid bills to the zone's "on-call veterinarian" will result in an outstanding account for the competitor, thus the competitor will not be able to compete at THJA South East Zone Show nor the championships until the account has been paid in full.

**Rules and Regulations: General**

Every class herein is governed by the rules and specifications of Equine Canada (EC) and will be held and judged

in accordance with the EC Rule (A602.2).

Statement of Principles: The Equestrian Canada Statement of Principles Section A: General Regulations, A602.3(f) as of 2021, The Statement of Principles has been moved from Rules of Equestrian Canada, to the Code of Conduct and Ethics, which can be found on their website under Governance.

- COMPETITION NUMBERS MUST ALWAYS BE WORN and VISIBLE
- DOGS MUST BE ON LEASHES AT THE SHOW
- Stabling is limited and must be arranged directly with the individual show facility. Stable request forms MUST be sent in to **endlessjourneyhorseshow@gmail.com** before the Monday of the show. Online stall requests WILL NOT be considered received without the Endless Journey Farm Stable Request Form, which is the final page of this document.
- Horse trailers must enter the driveway off VALLEY RD turn left and follow the signs to the stabling area. Empty trailers must be parked in the designated area.
- Protests, if any, must be made in writing and must be in the possession of the show secretary within 48 hours of the completion of the class concerned. No protests will be considered unless accompanied by a deposit of \$100.00 cash that shall be forfeited to the committee if said process is not sustained. (Article A1206). Protesting an animal's height requires a \$100.00 cash deposit. Protests are made through the steward at the show. There will also be Exhibitor Report forms available in the show office that can be submitted to the show office, the steward or directly to the OEF.
- Proper show attire, including jacket is required for all Hunter Divisions and equitation/Medal Classes and all Jumper classes. This includes all judged schoolings and clear rounds.
- Approved headgear: all competitors must wear proper fitting, ASTM approved protective head gear, with the safety harness correctly secured while mounted in competition or on event grounds.
- In the event of a fall, the exhibitor must leave the ring dismounted.
- Riders are allowed to show Hors Concours at the discretion of the Show Manager.

\*\*In the event of TRAINER CONFLICT -The ring that takes priority for that day will be announced and posted in the office. It is expected that a rider waiting for their trainer must be warmed and ready to show and waiting at the in gate. It is not acceptable to hold a ring for a hack or flat class.

Please consider the Equine Canada rules of conduct with respect to ringside manners and behaviours. The SE Trillium Circuit Competition(s) is sanctioned as Silver memberships of Equine Canada 208 Legget Drive Suite 100, Ottawa K2K1Y6 and is governed by the rules of EC. (A602-1)

- Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location. (A602.5)
- Per Article A801, every entry at an EC sanctioned competition shall constitute an agreement by the person responsible and the owner, lessee, trainer, manager, agent, coach, driver, or rider, or horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. (A602.7) It is the responsibility of all the individuals participating in any capacity in the EC sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any imposed by the competition. Do not participate in the EC sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the



competition.

### **Amateur Ruling:**

#### ARTICLE G108 Amateur Status

1. All Seniors competing in amateur classes at EC sanctioned competitions must possess a current EC amateur card, which is purchased annually at the price listed in the EC Schedule of Fees. Competitors in FEI sanctioned competitions must comply with the FEI definition of amateur.
2. A person competing in an EC amateur class must hold a valid EC senior sport license, have a current amateur card, and adhere to the following guidelines:
  - a) An EC amateur may hold an EC Instructor Beginner Certificate and teach within the context of the Instructor Beginner Certificate.
  - b) An EC amateur may accept remuneration for instruction of or coaching of the disabled.
  - c) An EC amateur may not accept remuneration for training a horse or for riding a horse at any EC sanctioned competition.
  - d) An EC amateur may not accept remuneration for coaching any person to ride or drive a horse including riding or driving clinics and seminars (See article G108 2.a for exemption)
  - e) An EC amateur may not train or show a horse, or instruct a rider or driver, when remuneration for this activity will be given to a corporation or farm which he or she or his or her family owns or controls.
  - f) An EC amateur may not act as an agent nor accept commissions for the sale, purchase, and/or lease of a horse.
  - g) EC amateurs may not use their name, photograph or any form of personal association as a horse person in connection with any advertisement or article sold without the approval and the signature of EC (e.g. product endorsement or advertisement of their activity as a coach).
  - h) An EC amateur may not enter into any form of sponsorship agreement. This is in conflict with the provisions of this article. See division rules for further information governing amateur status within divisions.
3. Persons who have not engaged in any of the activities in Article G108 (2ag) during the preceding two (2) calendar years may request reinstatement as amateur competitors.
4. Application for EC amateur status:
  - a) Amateur is issued by EC
  - b) For EC members, certification of amateur status is issued annually on EC sport license cards.
  - c) All persons wishing EC amateur status must complete and sign the amateur declaration, which is on the sport licence application /renewal form, affirming their eligibility.
  - d) Eligible amateurs who are not members of EC may receive amateur status issued by EC upon payment of fees listed in the current EC fee schedule.

### **Social Media Policy**

Social media has become extremely popular because it allows people to connect in the online world instantly to form relationships for personal and business purposes. It can take many different forms, including internet

forums, weblogs, social blogs, podcasts, pictures and video. Social media is becoming a part of the way very much we communicate with various audiences. Regular use of these channels of communication enables the THJA to maximize opportunities with dynamic information sources and allow the organization to market itself to a wider and more diverse audience. However, staff and members' use of social media can pose risks to the THJA's confidential and proprietary information, and reputation, and can jeopardize the THJA's compliance with legal obligations. This social media policy is designed to encourage the appropriate and effective use of social media platforms, as well as provide guidelines for staff/members to exercise personal responsibility when using social media. This policy does not form part of any employee's contract of employment and it may be amended at any time.

### Scope of Policy

This policy covers all individuals working and volunteering in the THJA at all levels. It also covers all members of the THJA and third parties who have access to the THJA's electronic communication systems.

Breach of this policy by THJA staff or volunteers may result in disciplinary action up to and including dismissal. Disciplinary action may be taken regardless of whether the breach is committed during working hours, and regardless of whether THJA equipment or facilities are used. Breach of this policy by a THJA member may, result in the Board suspending or terminating that member's membership of the THJA. The Board may also prevent such member from participating in THJA events and competitions. Any person suspected of committing a breach of this policy will be required to cooperate with THJA's investigations, which may involve handing over relevant passwords and login details. Staff, volunteers and members may be required to remove internet postings which are deemed to constitute a breach of this policy.

### THJA's Social Media Platforms

There are vast arrays of platforms to which the term 'social media' relates. However, the THJA has recognized the key channels most beneficial to the organization. These are:

- Twitter - a free social networking and micro-blogging service that enables its users to send and read other users' updates known as tweets.
- Facebook - allows users to create a personal profile, add other users as friends and exchange messages, including automatic notifications when they update their profile. Users may also join common interest user groups, organised by workplace, school or other characteristics.

This policy, however, applies to all forms of social media and all internet postings, including blogs.

### Appropriate Professional Use of Social Media

The THJA engages with social media on a professional level. If any THJA staff/members use social media channels they are asked to follow this policy and any other guidelines which are in place to ensure effective and appropriate usage. When using social media:

#### **You will:**

- Engage with social media platforms on a regular basis where appropriate
- Use appropriate language
- Think before you post any information online
- Ensure that your profile and any content you post are consistent with the professional image you present in respect of your association with the THJA

- Make it clear in postings that you are speaking on your own behalf. Write in the first person and use a personal email address when communicating via social media

If you disclose your affiliation with the THJA, you must state that your views do not represent those of the THJA. For example, you could state, “the views in this posting do not represent the views of the THJA.”

**You will not:**

- Upload content deemed disruptive, threatening, abusive, harassing, obscene, libellous or an invasion of another's privacy - this includes text, audio, photographs and video
- Use the THJA's name in a derogatory manner or defame or disparage the THJA
- Upload content deemed confidential by the THJA
- Infringe on the intellectual property of any company/individual - this can create liability for you and the THJA
- Use THJA logos, brands, slogans or other trademarks without the THJA's prior written consent
- Use inappropriate/irrelevant hashtags on Twitter
- Post personal messages through the THJA's pages on any social media platform
- Breach Data Protection requirements (for example, never disclose personal information about another member online)
- Breach any other laws or ethical standards (for example, use social media in a false or misleading way, such as by claiming to be someone other than yourself or by making misleading statements)

Staff, volunteers and members should never provide references for other individuals on social or professional networking sites, as such references can be attributed to the THJA and create legal liability for both the author of the reference and the THJA.

Social media is very much a part of the THJA's strategy moving forward and we encourage the professional use of the various channels on a regular basis.

The THJA does not discourage staff, volunteers or members from engaging with social media platforms for personal usage. However, guidelines are in place to ensure that you are using them appropriately and are not jeopardizing the organization with inappropriate use of personal profiles.

**Negativity on Social Media Platforms.**

It is important that social media platforms are monitored for negative comments about the THJA. If you are aware of negative comments posted on any of our pages, please make sure you speak to the THJA office directly to discuss it.

This policy is effective immediately and was last updated May 2015.

**Trillium Division Specs**

**TRILLIUM SILVER HUNTER MEDALS**

Originally created in the image of the Jump Canada Medal, the Trillium Medal class has evolved into a specialty class unique to the Trillium Circuit. Where contradiction exists, these specifications supersede those of the Equine Canada Jump Canada Medal. These classes are open to Junior and Amateur riders only. Riders may walk the course. Eligibility is as per individual hunter division specs for that particular medal.

*First Phase:* Over fences: Figure eight course of not less than eight jumps. Class is judged in accordance to Article G1008 Class Routine Over Fences. No additional test over fences is permitted.

*Second Phase:* On the Flat: All competitors, or a maximum of ten shall be called back to perform at walk, trot and canter. From a maximum of four competitors, the judge may call for a minimum of two or more requirements from Article G1009 Tests (Equine Canada Rule Book Section G).

*Scoring:* Medal classes will be judged 60% over fences and 40% on the flat.

*Tack & Equipment:* All tack and equipment remain the same for both phases. Restrictions as per Article G1003 through G1005.

### **TRILLIUM SILVER JUMPER MEDAL**

Originally created in the image of the CET Medal, the Trillium Jumper Medal has evolved into a specialty class unique to the Trillium Circuit. These specifications supersede those of the Equine Canada CET Medal. This class is open to Junior and Amateur riders only. It is judged with both a jumping and a flat phase. *Jumping Phase:* The jumping phase should be over a course of at least nine (9) fences. Fences will not exceed 3'3" in height with a spread not to exceed the height. The course must contain at least one double or triple combination with at least one spread fence. Other spread fences are required elsewhere on the course. A Liverpool is optional.

*Flat Phase:* All riders, or a maximum of twelve who complete the Jumping Phase, shall be called back to perform on the flat. During the flat phase, riders will show a working walk, the working trot sitting, the working trot rising, and showing a lengthening of stride, the working canter and the working canter showing a lengthening of stride. The working canter on the counter lead must be demonstrated for at least one full revolution of the ring in each direction. The top four riders in the flat phase will be asked to complete a short test determined by the judge. When this test is being ridden, the riders will turn their backs so they cannot watch the other competitors.

*Judging:* Jumping phase is to be conducted under current Equine Canada jumper rules. In addition, the class will be judged on seat, hand, guidance and control. Jumper Medal is to be judged 60% over fences and 40% on the flat. *Tack & Equipment:* All tack and equipment remain the same for both phases. Only running martingales used in the conventional manner are permitted. No Standing martingales, German martingales, draw reins or restricted running martingales are permitted. Conservative coloured headgear (As per Article G1109) must be worn, with no additional adornment. Stirrups are restricted as per Article G1109-G).

### **BRONZE MEDALS**

Originally created in the image of the Jump Canada Medal, the Trillium Medal Class has evolved into a specialty class unique to the Trillium Circuit. These specifications supersede those of the Equine Canada CET Medal. These classes are open to Junior and Amateur riders only. They are judged as equitation classes with both an over fence and a flat phase. Over fences phase to be ridden first and a maximum of 10 shall be called back for the flat

phase. Martingales are permissible, but draw reins are prohibited. Tack and equipment remain the same for all phases. Riders may walk the course.

a) **.90m Jumper:** Open to all horses and ponies. Maximum height of fences to be 0.90m. Run under Table A and FEI Article 238.2.2.2

b) **1.0m Jumper** - Fences 1 meter (3'3") Open to all horses. Adults are not permitted to ride ponies in this division. Maximum height of fences 1 meter. Run under Table A & FEI Article 238.2.2.2

c) **1.0m Jumper Medal** - Open to Junior and Amateur riders only. This class will have both an over fence and a flat phase, with the over fences phase being completed first. 50% of competitors, or a maximum of 12, shall be called back to complete the flat phase of the competition. Tack and Equipment of horse and rider as per Equine Canada Jumper rules for recognized jumper divisions and must remain the same for both phases. ### **SILVER EQUITATION**

Protective boots are permitted in equitation classes.

(d) A horse/pony ridden in an Equitation Over Fences class or in the Jumper Medal class may ONLY be ridden in that class by ONE rider.

(e) Modified Child Medal Class - Fences 2'9". Open to Junior riders riding horses that are competing in the Modified Child Hunter Division and the 2'6/2'9 Development Hunter Division. Top ten riders from this class maybe called back for additional testing on the flat.

(f) Modified Adult Medal Class - Fences 2'9". Open to Adult Amateur riders from the 2'9 Modified Adult Division and 2'6/2'9 Development Hunter Division. Top ten riders from this class may be called back for additional testing on the flat.

(g) Children's Medal Class - Fences 3'0". Open to Junior riders riding horses that are competing in the

Children Hunter Division and/or the Modified Junior/Amateur Hunter Division. Top ten riders from this class may be called back for additional testing on the flat.
